TAFINA MEETS BOT AND IPA

»»» The Innovation for Poverty Action (IPA) contacted TAFINA to share updates and seek input for the Tanzania Affordable Digital Finance Research Initiative (TADFRI) commissioned by the Bank of Tanzania. IPA will study DFS cost drivers like interoperability, taxation, competition, and regulation, using quantitative and qualitative methods to measure the impact of pricing changes on consumer uptake and usage. The goal is to develop strategies to increase DFS affordability and usage, providing evidence-based recommendations to the Bank of Tanzania, government authorities, and DFSPs.

Next Steps: <<<

- TAFINA members will have the opportunity to participate in Key Informant Interviews, starting with the impact of TIPS/interoperability on DFS affordability. We will reach out to members for these interviews to address their concerns and recommendations.
- We will organize a research dissemination session to share IPA's findings on the Transaction Cost Index Report. Stay tuned for more updates.
